## Solutions to AIEEE - 2008

Note: (i) The test is of 3 hours duration.

(ii) The test consists of 105 questions of 3 marks each. The maximum marks are 315.

(iii) There are three parts in the question paper. The distribution of marks subjectwise in each part is as under for each correct response.

## **Mathematics**

#### PART-A

He moves away from the pole along the line BC to a point D such that CD = 7 m. From D the angle of elevation of the point A is 45°. Then the height of the pole is




